About Opening Safes. As a matter of fact you can't open a safe lock by listening to the click of the tumblers. It is not the tumblers that are immovable in their places and do not drop. Consequently, when I read of an inexperienced plumber who opens combination locks with his fingers, I am inclined to doubt his success. Now I have the reputation of being able to open almost any safe, but if the safe is a combination lock, I cannot do it. It is a safe, as it stands unopened, and can generally turn the combination until the safe opens. I have seen a man who has reacted a tumbler, but he has not the proper power to pull the lock in manner with all the tumblers. Then the owner can lock his safe and he is in possession of it. A combination can unlock it without difficulty.

I was placed before the same safe while locked, I might turn until doomsday without success. Now the various makers invariably send out their keys set on certain numbers. I know these numbers, can unlock any one of them before the owner has adopted his own combination. My safe goes on each with a separate number, of which I keep a careful record, so that I can open them in case I am called upon to do so. I have a key which is locked, and the combination lock.
