Exciting Scenes at the Wind up of Prince Mike's Trial.

The Lecherous Fraud Gets Just Punishment of Five Years in Prison.

The trial of Prince Michael at Ann Arbor resulted in his conviction, and he was promptly sentenced to five years at Jackson.

The verdict was rendered at 8 o'clock in the evening, and an hour later the excitement reached a climax in one of the most sensational and exciting episodes ever experienced here.

A large crowd was attracted to the court house square by the vociferous demonstrations of the mob which surrounded the convicted prisoner as he was being taken back to jail.

The excitement has prevailed all day long that should Michael, by hook or crook, secure an acquittal, he would be lynched.

This sort of talk had aroused great feeling among the town people and students, and instantly as the prisoner was hustled into jail before harm was done, the excited people looked around for some other member of the gang upon whom they could vent their indignation.

The particular reason for this condition of public sentiment was the unnatural attitude of William Bickie toward his daughter Bernice on the witness stand.

It was about 9 o'clock when the first reports started as to where the offensive Israelites were stowed away, and it seemed that as if by one impulse the crowd made for the court house building.

The sheriff's office was locked, but this did not matter. A foot was lifted and the large plate glass window was sent in fragments to the floor.

Other missiles were hurled in the direction of the flying-haired Israelites, and in terror they dodged under a table in the room.

It was but a short time before the crowd had found entrance to the office, and the two men were thrown to the mercy of indignities.

Some demanded lynching, some tar and feathers, and others to cut their hair. By a mistake the crowd at first mistook Lucifer for Bickie, and he received even worse treatment than his real object of the crowd's indignation.

The mistake was corrected, however, and Lucifer was permitted to bump himself out of town, and he left the scene at a rate that would have made a sprinter envious.

Bickie was then taken out of the building, surrounded by two or three thousand people crowding and pushing, and everybody clamoring that some sort of punishment be inflicted upon him.

Bickie was almost speechless when he saw the demonstration and finally said to those near him: "What my hair? Do anything, but don't cut God's hair, kill me!"

This was made known to the crowd and the flying hair was hurled to the barber. The long haired disciple of the Flying Hair was hustled to Stevens' barber shop, opposite the court house, and seated in a chair.

Mr. Stevens went up to Bickie and asked: "Do you want your hair cut?" Bickie replied that he did and he was accordingly treated to a long delayed tonsorial operation, much to the delight of the crowd outside.

His hair fell rapidly under the scissors of the barber and in five minutes he felt the chair with his hair reduced to about half an inch length, and he was then hustled to the door. He mounted a chair in the barber shop, took off his coat and waved his hair to the crowd, who were shouting and cheering.
